## National Queen's Agreement

**Welcome to the NAM National Family!**  
**Please read thoroughly and sign the bottom of this agreement.**

1. As a National Queen for National American Miss, I promise to be a positive role model for all girls. My words and actions will be above reproach at all times. I will conduct myself in a moral and ethical manner. I will not smoke, use drugs, drink alcohol underage, use inappropriate language, or behave inappropriately while representing National American Miss. I will refrain from any racial slurs, personal, cyber, gender, or bullying of any type, as this behavior will not be tolerated, and may result in relinquishing my title for the year.
2. As a National Queen for National American Miss, I (we) give permission to National American Miss, Inc. to use any of my photos, videos, authored material, performances, testimonials, speeches, etc. for promotional purposes. It is also understood and accepted that they may appear in print, on video, in e-mail form, on the National American Miss website, on CD, on DVD, or other media.
3. As a National Queen for National American Miss, I will attend the National Pageant in Orlando, Florida during the week of Thanksgiving 2025 to crown my successor. It is understood that airfare, up to \$350, for the queen will be covered by the National Office. It is also understood that during the National Pageant, my family will receive a complimentary double/double hotel room for 8 nights at the host hotel. I will also receive \$100 activity day allowance, and up to 4 complimentary Thanksgiving Banquet tickets.
4. As a National Queen for National American Miss, I will try to the best of my ability to promote the National American Miss Program throughout my hometown and state by making appearances in the National American Miss Official National Banner (and crown, when appropriate) when riding in parades, doing Community Service, distributing pageant invitational literature, and visiting celebrities and politicians.
5. At National American Miss we value community service. As a National Queen, I will set a good example for girls across America by volunteering *at least* 40 hours of my time doing community service before the 2024 National Pageant. Please document your service with photos on your official social media handles.
6. As a National Queen for National American Miss, it is understood that all printed materials I receive are copyrighted and are owned solely by National American Miss, Inc. They should not be copied or distributed without the consent and knowledge of the National Office.
7. As the parent of a National American Miss National Queen, I will monitor my daughter's social networking sites including, but not limited to, Facebook, Instagram, Twitter, TikTok, at least twice a month. I will remove any language, music or photographs that do not reflect the image of a positive role model in keeping with item #1 of this agreement.
8. As a national queen, we are asking that for this year you focus on representing your title with National American Miss. As you may know, we do not have a rule in our system that State Queens cannot compete in other pageants. However, due to the expected commitment of our National Queens throughout their year of their reign, National Queens are NOT allowed to compete in nor hold any other local, state or national title until after the 2025 National Pageant. *This is a steadfast policy of National American Miss. Any National Queen holding or competing for a local, state or national title during the time of her reign will be subject to being relieved of her title and must forfeit all remaining National prizes.*
9. Throughout the year of my reign, I will continue to follow all of the rules for my age division as if I were competing. This applies to clothing, hair, make-up, etc.

10. Throughout the year of my reign, I will commit to promoting all National American Miss sponsors on my NAM official social media and promote and use their services when made available to me on location. This includes but isn't limited to hair and makeup services, clothing and jewelry sponsors, gown and dress sponsors, etc.
11. I will not promote, tag (either on image or in caption) any product, service, coach or otherwise via Official Accounts unless they are an Approved or Elite Powerhouse Sponsor. If I am uncertain, I will ask before I post.
12. I will be happy to help any NAM contestant prepare for their pageant by answering questions and giving advice about dresses, personal introductions, etc. I or my immediate family member will help them out as a friend, but not as a coach and/or trainer. I, nor any member of my immediate family, will receive any form of compensation for our efforts during the year of my reign.
13. I have received my Official National Crown, and it is in good condition! If my crown is damaged during the year, I will be responsible for having it repaired or replaced.
14. I have received my Official National Banner and it is in good condition. This banner is a trademark of National American Miss which exemplifies our prestigious pageant system. At no time should you ever redesign or deface your banner in anyway. You may not add any type of stones to the front or the back of your banner. You may not permanently add any design or wording to the front of your banner. The only thing that you can add permanently to the back of your banner is your first name which the National Office will do for FREE as part of your National Prize Package. I will not alter banner in any way. If my banner is lost or damaged during the year, I will be responsible for repairing or replacing it.
