

2024-2025 International Queen's Agreement

Welcome to the IJM International Dynasty!
Please read thoroughly and sign the bottom of this agreement.

1. As an International Queen for International Junior Miss, I promise to be a positive role model for all girls. My words and actions will be above reproach at all times. I will conduct myself in a moral and ethical manner. I will not smoke, use drugs, drink alcohol underage, use inappropriate language, or behave inappropriately while representing International Junior Miss. I will refrain from any racial slurs as well as any personal, cyber, gender bullying of any type, as this behavior will not be tolerated, and may result in relinquishing my title for the year.
2. As an International Queen for International Junior Miss, I (we) give permission to International Junior Miss, Inc. to use any of my photos, videos, authored material, performances, testimonials, speeches, etc. for promotional purposes. It is also understood and accepted that they may appear in print, on video, in e-mail form, on the International Junior Miss website, on CD, on DVD, or other media.
3. As an International Queen for International Junior Miss, I will attend the 2025-2026 International Pageant in Orlando, Florida to crown my successor. While the final schedule is being worked on, I will plan to be available December 31st, 2025 through December 4th, 2026 for next year's event. It is understood that airfare, up to \$350, for the queen will be covered by the International Office. It is also understood that during the International Pageant, my family will receive a complimentary double/double or queen/queen hotel room for all nights at the host hotel, the Hyatt Regency Orlando.
4. As an International Queen for International Junior Miss, I will try to the best of my ability to promote the International Junior Miss Program throughout my hometown, state, country, and abroad by making appearances in the International Junior Miss Official International Banner (and crown, when appropriate) when riding in parades, doing community service, distributing pageant invitational literature, and visiting celebrities and politicians.
5. At International Junior Miss we value community service. As an International Queen, I will set a good example for girls across America by volunteering *at least* 40 hours of my time doing community service before the 2025-2026 International Pageant in January 2026. Please document your service with photos on your official social media handles using the "Service" highlight on your Official Instagram account.
6. As an International Queen for International Junior Miss, it is understood that all printed materials I receive are copyrighted and are owned solely by International Junior Miss, Inc. They should not be copied or distributed without the consent and knowledge of the International Office.
7. As the parent of an International Junior Miss International Queen, I will monitor my daughter's social networking sites --- including, but not limited to, Facebook, Instagram, Twitter, and TikTok --- at least twice a month. I will remove any language, music or photographs that do not reflect the image of a positive role model in keeping with item #1 of this Agreement.
8. As an International Queen, when it comes to the world of pageantry, we are asking you to solely focus on representing your title with International Junior Miss. Due to the expected commitment of our International Queens throughout their year of their reign, International Queens are NOT allowed to compete in nor hold any other local, state, national, or international title until after the 2025-2026 International Pageant. If you are currently holding any other titles, you must disclose them now and relinquish them for this season. You may not appear in any other crown or banner representing any of other system throughout your reign so as not to confuse our organization and branding with any other. *This is a steadfast policy of International Junior Miss. Any International Queen holding or competing for a local, state, national or international title during the time of her reign will be subject to being relieved of her title and must forfeit all remaining International prizes in addition to being liable for any payments and prizes previously presented.*
9. Throughout the year of my reign, I will continue to follow all of the rules for my age division as if I were competing. This applies to clothing, hair, make-up, etc.

10. Throughout the year of my reign, I will commit to promoting all International Junior Miss sponsors on my IJM official social media and promote and use their services when made available to me on location. This includes but isn't limited to hair and makeup services, clothing and jewelry sponsors, gown and dress sponsors, etc.
11. I will not promote, tag (either on image or in caption) any product, service, coach or otherwise via Official Accounts unless they are an Approved or Elite Powerhouse Sponsor. If I am uncertain, I will ask before I post. I have noted that IJM also respectfully requests that posts made on personal accounts – either belonging to the Queen or her pageant/guardian – refrain from highlighting those who are not sponsors of International Junior Miss in context of IJM and the titleholder's capacity as an IJM Titleholder.
12. I will be happy to help any IJM contestant prepare for their pageant by answering questions and giving advice about dresses, walking patterns, etc. I or my immediate family member will help them out as a friend, but not as a coach and/or trainer. I, nor any member of my immediate family, will receive any form of compensation for our efforts during the year of my reign. I will also not participate in any coaching efforts such as mock interviews or training camps, unless expressly permitted in writing from the International Director.
13. I have received my Official International Crown, and it is in good condition! If my crown is damaged during the year, I will be responsible for having it repaired or replaced.
14. I have received my Official International Banner and it is in good condition. This banner is a trademark of International Junior Miss which exemplifies our prestigious pageant system. At no time should you ever redesign or deface your banner in anyway. You may not add any type of stones to the front or the back of your banner. You may not permanently add any design or wording to the front of your banner. The only thing that you can add permanently to the back of your banner is your first name which the International Office will do for FREE as part of your International Prize Package (we will give you a second banner with your name). I will not alter banner in any way. If my banner is lost or damaged during the year, I will be responsible for repairing or replacing it.

IN CONSIDERATION FOR BEING ACCEPTED AS A INTERNATIONAL QUEEN FOR INTERNATIONAL JUNIOR MISS, A DIVISION OF THE PAGEANT POWERHOUSE DBA AS NATIONAL AMERICAN MISS INC, WE THE PARENTS AND/OR GUARDIANS OF THE QUEEN INDIVIDUALLY NAMED BELOW, DO HEREBY RELEASE INTERNATIONAL JUNIOR MISS, ITS STAFF, DIRECTORS, FRANCHISEES, SUBSIDIARIES, ASSIGNEES, EMPLOYEES AND SERVANTS FROM ANY AND ALL CLAIMS AND DAMAGES DIRECTLY OR INDIRECTLY RESULTING FROM NAMED QUEEN PARTICIPATING IN THE INTERNATIONAL JUNIOR MISS PAGEANT; AND WE GIVE PERMISSION TO INTERNATIONAL JUNIOR MISS, A DIVISION OF THE PAGEANT POWERHOUSE DBA AS NATIONAL AMERICAN MISS, INC. TO USE THE QUEEN'S PHOTOGRAPHS, SPEECHES, TESTIMONIALS, VIDEOS, ETC., FOR PUBLICITY PURPOSES AND FUTURE MATERIAL. WE AGREE TO THE TERMS LISTED ABOVE AND ARE EXCITED ABOUT OUR YEAR AS AN INTERNATIONAL QUEEN FOR INTERNATIONAL JUNIOR MISS!

2024-2025 Powerhouse Brand Ambassador Agreement

This Powerhouse Brand Ambassador Agreement (the "Agreement") is entered into on _____ between National American Miss and The iam Pageant Powerhouse, hereinafter referred to as "The Powerhouse," and _____, hereinafter referred to as the "Brand Ambassador."

1. Exclusive Representation:

The Brand Ambassador agrees to exclusively represent The Powerhouse and its sponsors throughout the duration of their reign, which includes but is not limited to wearing the crown and/or banner, posting on the official account, accepting tags on the official account, appearing in posts identifying them as a titleholder, and/or resharing stories or other content on any account, official or otherwise.

2. Modeling and Media Content:

The Brand Ambassador may not model or appear in print, commercial, or media content advertising any store, designer, service, or product without the prior written request and permission of The Powerhouse. The Brand Ambassador may not promote, endorse, or otherwise advertise for any store, designer, service, or product that is not an Approved or Elite Powerhouse Sponsor. This includes making appearances on behalf of your role or in conjunction with your role as a Brand Ambassador and/or residual content from said appearances while wearing the crown and/or banner, posting on the official account, accepting tags on the official account, appearing in posts identifying them as a titleholder, and/or resharing stories or other content on any account, official or otherwise.

3. Approval Process:

The Brand Ambassador must seek prior written approval for any modeling engagements or media appearances. The Powerhouse reserves the right to deny permission for any appearance that conflicts with the exclusive representation agreement.

4. Use of Images and Likeness:

The Brand Ambassador agrees that their image and likeness are exclusive to The Powerhouse and its sponsors throughout the duration of their reign. The Brand Ambassador acknowledges that unauthorized use of their image and likeness for promotional purposes may result in termination of this Agreement. The Brand Ambassador acknowledges that photos taken by The Powerhouse, during the National Photo Shoot, or any other event, may not be distributed or shared with other people or business. Usage of The Powerhouse photos for promotion by any store, designer, service, or product that is not an Approved or Elite Powerhouse Sponsor is strictly prohibited.

5. Transparency and Communication:

The Brand Ambassador agrees to communicate openly and transparently with The Powerhouse regarding any concerns or questions about potential conflicts with this Agreement. The Powerhouse will follow up directly if there are any concerns about content already posted.

6. Duration:

This Agreement shall be effective from crowning and shall continue until the Brand Ambassador passes on her title.

7. Miscellaneous:

The Brand Ambassador understands that this Agreement is crucial for the marketing efforts of The Powerhouse and its sponsors. Any breach of this Agreement may result in the termination of the Brand Ambassador's title.
